Pt II Ln 17a: The organization's public support is below the 33 1/3rd% amount and is currently at 27% and the prior year was 22%. So the organization is making significant progress improving it's public support. It meets all the relevant facts and circumstance factors in Â§ 1.170-9(f)(3) to continue qualifying as a public charity. Specifically, the organization has an ongoing and bona fide fundraising program which includes regular mailings to report on the charitable work and developments and solicit donations. The organization also holds in person fundraisers which have been the most effective way for the organization to both raise awareness of its charitable work in Nigeria and to solicit funds from the general public. However, due to COVID, the in-person events were not permitted to occur in person during 2020 and 2021, which prevented the organization from making more significant headway on its public support percentage. There are no related parties on the Board and the Board is composed of a diverse group of religious leaders and volunteers committed to serving the poor and marginalized orphans and widows in Nigeria. The organization currently conducts a poverty relief program to provide food, shelter, medical care, and clear water to those in need in Nigeria and funds teacher salaries in two villages in Nigeria. The organization continues to pursue funding from other public charities and private foundations. Further, it believes that, if it were not for COVID, its fundraising efforts would have continued to be at or above the 33 1/3%. For all these reasons, the organization believes it satisfies the facts and circumstances test set forth in Treas. Reg. Â§ 1.170A-9(f)(3) and therefore qualifies as publicly supported.
