AS A RESULT OF THE SHUTDOWN CAUSED BY THE COVID-19 PANDEMIC, TAPROOT THEATRE COMPANY WAS ONLY ABLE TO COMPLETE ONE PRODUCTION FOR ITS SUBSCRIPTION SEASON IN THE JEWELL AUDITORIUM, AND ONE PLAY IN THE ISAAC STUDIO THEATRE IN 2021; THE COMBINED ATTENDANCE WAS APPROXIMATELY 5,417 PEOPLE.

IN 2021, THE ROAD COMPANY PERFORMED IN 130 PERFORMANCES TO APPROXIMATELY 41,738 STUDENTS.
