AS A RESULT OF THE SHUTDOWN CAUSED BY THE COVID 19 PANDEMIC, TAPROOT THEATRE COMPANY WAS ONLY ABLE TO COMPLETE ONE PRODUCTION FOR ITS SUBSCRIPTION SEASON IN THE JEWELL AUDITORIUM, AND ONE PLAY IN THE ISAAC STUDIO THEATRE IN 2020; THE COMBINED ATTENDANCE WAS APPROXIMATELY 4,500 PEOPLE.

THE TAPROOT THEATRE'S ROAD COMPANY CONSISTS OF 5 ACTORS WHO PERFORM SOCIAL-ISSUE PLAYS AT PUBLIC AND PRIVATE SCHOOLS. THESE PLAYS FOCUS ON BULLYING, CYBER-BULLYING PREVENTION, MAKING AND MAINTAINING FRIENDSHIPS, AND EMPATHY AND EMOTIONAL MANAGEMENT. IN 2020, THE ROAD COMPANY PERFORMED IN 149 PERFORMANCES TO APPROXIMATELY 63,400 STUDENTS. THE NUMBER SERVED WAS GREATLY REDUCED IN 2020 AS A RESULT OF THE SHUTDOWN CAUSED BY THE COVID 19 PANDEMIC.
