

1. Form 990, Part III, Line 4a: Helping Up Mission offers a wide range of Recovery Programs and Services for homeless and chemically addicted men. The heart of our work is the Spiritual Recovery Program, which focuses on the four key areas of life: the intellectual, physical, spiritual and social needs of each client. Our work is accomplished through a comprehensive array of programs and services including Spiritual Recovery, Transitional Housing, Educational Programs, Vocational Programs, Mentoring, Counseling, Work Therapy and Art Therapy.

From early in the Mission's history, providing Emergency Overnight Services has been a primary focus of the Mission. Each night these men are provided with a shower, a clean set of clothing, two hot meals and a message of hope that "real and permanent" change is possible. During their stay, overnight guests are served by and have the opportunity to interact with the men in our Spiritual Recovery Program. As a result of seeing dramatic changes in the lives of men who formerly shared their circumstances, many guests also choose to join the 12-month program. Last year, almost one out of three Spiritual Recovery Program members came out from our Emergency Overnight Services.

At Helping Up Mission we provide a vast array of services to an even more diverse group of men. The average age of the men we serve is 40, with an average length of addiction of 20 years. Approximately 58% of our clients are from Baltimore City, and others are from other jurisdictions in the Baltimore Metropolitan area including Baltimore County (18%), Anne Arundel County, Howard County, Harford County, and Queen Anne's County.

Over the course of the past year we provided the following to our clients:

- 900+ meals served each day
- 328,500+ meals served each year
- 125,000 nights of available shelter annually
- 18,000 pieces of clothing distributed annually
- 1,500 chapel services and educational classes conducted each year

In addition to the services listed above, Helping Up Mission partners with other local nonprofits to provide services to our clients. Below, you will find some of the other services we provided in 2008/9:
