GARDEN CITY HARVEST WAS ESTABLISHED IN 1996 AS THE COMMUNITY'S ONLY PROACTIVE SOLUTION TO FOOD INSECURITY TO ENSURE PEOPLE COULD MEET THEIR BASIC NEEDS FOR NUTRITIOUS FOOD. THE FARMING AND GARDENING NONPROFIT NOW MANAGES 21 FARMS, COMMUNITY GARDENS, AND SCHOOL GARDENS THROUGHOUT MISSOULA, MONTANA'S URBAN CORE. ITS MISSION IS CARRIED OUT THROUGH FOUR PROGRAMS THAT AFFECT MORE THAN 20,000 COMMUNITY MEMBERS ANNUALLY.

THE COMMUNITY GARDENS PROGRAM OFFERS COMMUNITY MEMBERS THE OPPORTUNITY TO AFFORDABLY GROW FOOD TO FEED THEIR OWN FAMILIES. ROUGHLY 65% OF PARTICIPANTS LIVE IN LOW TO MODERATE-INCOME HOUSEHOLDS WHERE BUDGETS ARE TIGHT.
