THE FARMING AND GARDENING NONPROFIT CURRENTLY MANAGES 21 FARMS, COMMUNITY GARDENS, AND SCHOOL GARDENS THROUGHOUT MISSOULA, MONTANA'S URBAN CORE. ITS MISSION IS ENACTED THROUGH FOUR PROGRAMS THAT AFFECT MORE THAN 20,000 COMMUNITY MEMBERS ANNUALLY.
