CLIENTS ARE ABLE TO CHOOSE FROM FRESH PRODUCE AND MEATS, BAKERY ITEMS AND NON-PERISHABLES BASED ON HOUSEHOLD NUTRITION NEEDS AND PREFERENCES. SERVING AN AVERAGE OF 233 HOUSEHOLDS PER MONTH, 188,277 LBS OF FOOD, VALUED AT \$325,633, WAS DISTRIBUTED TO NEIGHBORS IN NEED. AN ADDITIONAL 25,636 POUNDS OF FOOD, VALUED AT \$44,350, WAS DISTRIBUTED TO OTHER NON-PROFIT ORGANIZATIONS FIGHTING HUNGER IN THE CHARLESTON COMMUNITY.
