In 2016, we opened a second aftercare home serving survivors. This is the first program dedicated to this demographic in East Africa. We developed prevention programs and began advocacy work on a national scale. To date, we have provided aftercare services to more than 200 survivors or human trafficking.

Restoration: We provide restorative care to survivors of human trafficking through our two after care homes in Kampala, Uganda. In 2017, we served 58 survivors of trafficking, and we saw 9 survivors graduate and resettle. We also opened a new aftercare program for transnational survivors, the first of its kind in the region. Our social workers provided 416 hours of counseling. 377 survivors were granted education scholarships. Furthermore, our social workers provided 246 therapy sessions. At our aftercare homes, 3,500 health meals were served.

Prevention: We prevent trafficking through advocacy, awareness, and education. We launched a victim advocacy program in 2017. As a result, 7 cases were brought to court.

Partnership: We work together with organizations, governments, corporations, and individuals to share resources and increase impact. We launched an anti-trafficking coalition in Uganda to increase partnerships in the sector. Additionally, we developed new partnerships to expand prevention and protection efforts.
