THE GOAL OF THE PROGRAM IS TO RAISE AWARENESS ABOUT THE IMPORTANCE OF MAKING CLIMBING ACCESSIBLE AND INSPIRING CLIMBING GYMS TO BE TRAINED IN PARADOX SPORTS ADAPTIVE CLIMBING TECHNIQUES. THROUGH THE ADAPTIVE CLIMBING INITIATIVE, MORE THAN 350 PEOPLE HAVE BEEN TRAINED ON OUR PROGRAMS AND EACH NOW HAS THE SKILLS NEEDED TO FACILITATE ADAPTIVE TECHNIQUES IN ACTIVITIES, WHICH HAVE HELPED MORE THAN 200 PEOPLE WITH DISABILITIES WHO HAD THE CHANCE TO TRY CLIMBING FOR THE FIRST TIME.
