The Delta Gamma Center for Children with Visual Impairments is committed to helping children who are blind or visually impaired See Form 990, Page 2, Part III, Line 1 (continued)

Home and community based education: 178 families with infants and toddlers who are blind or visually impaired received service through this program from teachers of the visually impaired, occupational, physical and speech therapists. Total hours of service provided were 4,689 hours, including classes, home visits, therapy services and assistive technology. Individual goals were established for each child to guide services, and 87 % of children accomplished or made substantial progress toward their goals.

4b (Code:) (Expenses \$ 200,253. including grants of \$ 117,441.) (Revenue \$ 19,279.)

Group and individual support for families: Individual and group support services were offered for all family members including parents, grandparents siblings, and a variety of family activities. 116 families (including 307 family members) participated in 1,376 hours of service throughout the year. Direct support to school age children who are blind or visually impaired was provided throughout the year by the GRADS programs which had 48 participants who received a total of 2,297 hours of service.

Outreach Services: Includes a wide array of services to increase awareness and understanding in the St. Louis area about pediatric visual impairments. Accomplishments include vision screening for 1,809 pre-school children, ability awareness provided to a total of 450 children in area schools, and training for pediatric and ophthalmology residents at Washington University School of Medicine.
