The Center raises and responds to ethical issues in health and healthcare by bringing experts on the staff and around the US together with interested members of the community to seek common ground on the most difficult ethical issues related to aging, end of life/advance care planning, balanced pain policy, pediatric palliative care, life science and research ethics, clinical and organizational ethics and disparities in health and healthcare. The results of these efforts are greater understanding of issues and often guidelines that can help families, clinicians, hospitals, nursing homes, and patients be better able to make difficult decisions. Center staff train and support hospitals' ethics committees and are called on to provide presentations on bioethics across the country. Information is made available through consultation, workshops, lectures, symposia, on-line discussion, podcast, blogs, website and other presentation formats and is interactive whenever possible. Programs are educational and provide fact-based information that is unfettered by special interest.
