Other: Our Forests Aren't Fuel (OFAF) -Policy makers in Europe and the United

States are promoting the burning of wood as a "renewable" climate friendly alternative

coal for electricity generation under the guise of "renewable energy" even though

the science documents that burning wood releases more carbon than coal per unit

of electricity generated and further degrades forests. Over the past several

years, the forests of the Southern US have been the target of this growing global

market. In response, in 2013 Dogwood Alliance, launched the Our Forests Aren't

Fuel campaign educating and activating citizens, policy makers and industry on

both sides of the Atlantic to stop the further expansion of this industry. This

campaign continued to be a major focus of work in 2020 leveraging significant

results. State, national and international concern about industrial biomass grew

significantly in 2020, as communities and government officials publicly challenged

the industry's "renewable" and "sustainable" claims. During the year our campaign

with partners launched the Cut Carbon Not Forests campaign in the United Kingdom.

This coordinated effort generated significant media attention and over 2000 direct

contact with officials in the UK within the first few months. Our work in the

Netherlands with local partners has also resulted in a significant shift in public

opinion towards biomass. A 2020 public survey in the Netherlands showed that

now 98% of citizens oppose further subsidies for biomass. In combination with

ongoing work in Denmark, our international work in 2020 set up the Our Forests

Aren't Fuel campaign for major victories on biomass in the EU in 2021 and beyond.

In our focus area of North Carolina, 2020 started with a major 4 part series

in North Carolina's major papers - the Raleigh News and Observer and Durham Herald

Sun - on the biomass issue. Our campaign had worked for months with the reporters

and provided background for the stories. Raleigh News Observer - "Slow Burn" (4 part series). Following this high profile media coverage in the State, we secured a meeting with high-ranking officials within the Cooper Administration, including the NC Secretary of the Department of Environmental Quality. Our subsequent work with the local community in Robeson County, NC to stop another wood pellet mill resulted in NC DEQ delaying the permit twice. Though the permit was ultimately granted, this work kept the issue of wood pellets at the forefront in NC, throughout the South and at the international level. It also resulted in expanded opposition to wood pellets and support for greater forest protection at the local and state level. The issue of wood pellets is now a priority issue within the Governor's Environmental Justice Task Force. We also continued to provide support and resources to groups on the ground throughout NC, in SC, in GA and in AL and MS for challenging the expansion of the wood pellet industry.

Other: Wetland Forest Initiative (WFI) - Wetland forests in the US South span nearly 35 million acres across 14 states and are critical for community health and safety. They have some of the highest rates of biodiversity and carbon sequestration of any forest type in the US. In 2016, Dogwood Alliance, Inc. launched the Wetland Forests Initiative (WFI) to engage partners, citizens, political leaders, landowners and many others in a legacy landscape conservation initiative to protect millions of acres throughout the Southeast. Dogwood's leadership in protecting critical wetland forests in the South from industrial logging, including biomass, gained momentum in 2020 - specifically within communities who are being most impacted by industrial logging. Our work in partnership with the Pee Dee Indian Tribe is supporting their vision of establishing a cultural and environmental center on their land where people can learn about the tribe, its culture and the importance of protecting wetland forests in the Pee Dee Watershed of South Carolina. The

tribe is using Dogwood materials and resources to educate the community about the value of wetland forests and to build some outdoor recreation infrastructure on their land as an example of how the community could benefit from an outdoor recreation economy and transition away from logging wetland forests. In partnership with New Alpha CDC, we continued outreach in the community of Brittons Neck, SC - also in the Pee Dee Watershed. We held monthly zoom calls with 10 community leaders about the importance of protecting wetland forests for flood control and for building an outdoor recreation economy. Our community partners in Brittons Neck, SC we're able to distribute over 1000 flyers - going door to door talking about wetland forest protection. Our work in the Pee Dee Watershed with the Pee Dee Tribe and Britton's Neck Community is designing a model for community-led wetland forest solutions that can serve as a model for rural communities across the South.

Other: Forests and Climate (F&C) - The Paris Climate Agreement gave the world a charge: decarbonize all energy sectors and simultaneously remove carbon dioxide from the air. The best and most cost-effective technology we have to remove carbon from our atmosphere right now lies in the power of forests. Standing forests are the natural life support that we need to mitigate the worst impacts of climate change and protect those most profoundly impacted, often low income communities and people of color. Logging in the US releases large amounts of carbon into the atmosphere while simultaneously degrading the nation's forests ability to provide critical climate benefits. Despite these facts, forest protection continues to remain on the sidelines of the national climate agenda and renewable energy policy in the US. Dogwood Alliance's new forest and climate program is designed to shift this dynamic, by elevating climate, forest and community impacts created by industrial logging in the US, while providing conservation solutions

that place the needs of those most impacted at the forefront. Dogwood Alliance has continued to be a national leader, working at the intersection of forests, climate and justice. Our focus on deepening partnerships and strategic communications created opportunities to influence policy and policy makers at the state and national level. In 2020, our influence grew through a webinar series entitled "The Perfect Storm: US Forests and the Climate Emergency" which engaged hundreds of individuals from around the county. As well as several major national media stories, elected official briefings at the national and state level, and a Stand4Forests report series that worked to bust widespread industry greenwashing. In partnership with Southern Climate and Energy Network, Gulf Coast Center for Law and Policy, and New Alpha Development Corporation, Dogwood Alliance is co-leading an effort to unite the Southern climate justice movement behind a climate and green jobs policy platform that centers the needs of Southern front-line communities. A major portion of the platform focuses on issues of forests and climate. This platform will be launched and used to influence state and federal policy in 2021 and beyond. Dogwood also continued working at the state levels in North Carolina and Georgia to advance policy to protect forests. In 2019 through 2020, Dogwood Alliance participated in the forestry subgroup to provide input on NC's Climate Risk and Resiliency Plan, which was released in 2020. This plan, endorsed by the Governor, calls for increased protection for millions of acres of forests in NC. In Georgia, our work resulted in bi-partisan support for a resolution calling for increased protection for forests that was introduced into the House and Senate natural resource committees.
