THIS PILOT PROJECT WILL INCLUDE A CONTROL SAMPLE AS WELL AS A TRIAL SAMPLE OF VETERANS WHO STRUGGLE WITH EMOTION REGULATION AND SOCIAL ENGAGEMENT.
