Through its emergency relief and recovery programs, CERF+ provided emergency relief counseling and support, referrals to other assistance and resources, and loan management to two hundred and fifty artists seeking assistance in FY12. In addition, CERF+ distributed \$130,391 in immediate financial assistance and brokered donations of equipment, materials and services to fifty craft artists following a range of career-threatening emergencies such as floods, fires, illness and injury.

CERF+'s programs on emergency planning and preparedness served four hundred seventy-two individuals with business counseling, webinars, and workshops in FY12. During this time, the organization distributed 435 copies of its "Studio Protector"-a disaster planning and preparedness toolkit for artists. CERF+ also continued to enhance the Studio Protector companion website (studioprotector.org) by improving overall design and functionality of the site and adding new articles, blogs, resources and more artist-to-artist videos. During this time, the Studio Protector web site had 8,930 visits with 45,846 page views. CERF+ also began working with faculty at four art schools to develop

The National Coalition for Arts Preparedness and Emergency Response: CERF+ co-chairs this national coalition of arts organizations, which consists of national, regional, state and local arts councils and funders, along with the National Endowment for the Arts, that are working together to improve the overall safety-net for the arts sector before, during, and after emergencies. During FY12, the Coalition was strengthened with the hiring of a part-time coordinator. This made possible an increase in the Coalition's services to the field before and after disasters. Also during this time, and with CERF+'s leadership, the Southern California Arts Responder Network
