Casa Pacifica's residential based programs include an Emergency Shelter, Residential Treatment Center, and Transition Age Youth program. Clinical services are fully integrated with these programs and provide psychological and social/emotional assessments, case management, individual, group, and family therapy, medication support, and crisis intervention. During FY15/16 we served over 280 children, youth, and young adults in these programs.

4b (Code:) (Expenses \$ 10,529,602. including grants of \$) (Revenue \$)

Casa Pacifica provides a variety of community based programs with a goal of keeping children who are in jeopardy of "out of home" placement in their own homes and communities. These programs work with youth and families in-home, in-school, and wherever else services are needed. Services include Therapeutic Behavioral Services, Wraparound, Mobile Crisis Response, Family Connections, Intensive Family Services, and Foster Family Agency. During FY15/16 we served over 3,000 youth and their families through these programs.

Casa Pacifica's Non-Public Special Education School is a WASC accredited, diploma-granting institution that serves special needs children in grades 1 to 12 with primary diagnoses of emotional disturbance, autism, other health impairment and specific learning disabilities. The school is located on our main campus and serves youth placed in our residential based programs as well as day students from surrounding communities. During FY15/16 there were 69 students that attended the school.
