CLINICAL SERVICES ARE FULLY INTEGRATED WITH THESE PROGRAMS AND PROVIDE PSYCHOLOGICAL AND SOCIAL/EMOTIONAL ASSESSMENTS, CASE MANAGEMENT, INDIVIDUAL, GROUP, AND FAMILY THERAPY, MEDICATION SUPPORT, AND CRISIS INTERVENTION. DURING FY 17/18 WE SERVED OVER 214 CHILDREN, YOUTH, AND YOUNG ADULTS IN THESE PROGRAMS.

SERVICES INCLUDED THERAPEUTIC BEHAVIORAL SERVICES, WRAPAROUND, MOBILE CRISIS RESPONSE, AND FOSTER FAMILY AGENCY. DURING FY 17/18 WE SERVED OVER 1,854 YOUTH ADN THEIR FAMILIES THROUGH THESE PROGRAMS.
