THE SAN DIEGO BLOOD BANK PRIMARILY REACHES OUT TO THE NEARLY 3.1 MILLION PEOPLE RESIDING IN SAN DIEGO AND IMPERIAL COUNTIES, WHILE THE 50 HOSPITALS SERVED BY THE SAN DIEGO BLOOD BANK THROUGHOUT THE FIVE COUNTIES HAVE A COMBINED POPULATION OF OVER 17.6 MILLION.

THE SAN DIEGO BLOOD BANK ASSISTED IN PROVIDING 5 UMBILICAL CORD BLOOD AND 13 BONE MARROW TRANSPLANTATIONS DURING THE REPORTING YEAR.
