LET GROW CHOSE NOT TO APPLY FOR THE GOVERNMENT'S PPA LOANS, AND WAS ABLE TO CONTINUE OPERATIONS THROUGH A COMBINATION OF A REDUCTION IN FORCE, AND EMERGENCY FUNDING FROM A COUPLE FORMER LARGE DONORS. THE ECONOMIC CONSEQUENCES OF SHUTDOWNS AND LACK OF DEVELOPMENT STAFF ALSO MADE IT CLOSE TO IMPOSSIBLE TO DIVERSIFY OUR FUNDING SOURCES DURING THE PAST FEW YEARS, BUT WE ARE COMMITTED TO DOING SO AND MAKING PROGRESS. OUR SERVICES ARE AIMED AT PARENTS AND SCHOOLS, AND WE WERE ABLE TO DIRECTLY BENEFIT PARENTS THROUGHOUT THE SCHOOL CLOSURES, AND HAVE BEGUN REBUILDING OUR SCHOOL SERVICES.
