Eve's Fund for Native American Health Initiatives

Eve's Fund for Native American Health Initiatives, a nonprofit corporation organized and existing under the laws of the New Mexico Nonprofit Corporation Act (the "Corporation"), hereby certifies as follows:

- 1. The Corporation was incorporated on June 13, 2005, with NMPRC# 2600765;
- 2. The Corporation amends Article Three to include such language as set forth in the last paragraph within Article Three;
- 3. Pursuant to section 53-8-39 of the New Mexico Nonprofit Corporation Act, this Amended and Restated Articles of Incorporation restates and integrates and amends the provisions of the Articles of Incorporation of the Corporation; and
- 4. The following Amended and Restated Articles of Incorporation correctly set forth the provisions of the Articles of Incorporation, as amended, and have been duly approved as required by law and supersede the original Articles of Incorporation and all amendments thereto:

ARTICLE ONE

The name of the Corporation is Eve's Fund for Native American Health Initiatives.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the Corporation is organized is to provide health-related education, prevention, treatment, and other charitable services primarily to Native Americans.

The Corporation is a nonprofit corporation, organized under the New Mexico Nonprofit Corporation Act, and its purpose falls under one or more of the purposes enumerated in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. The Corporation may engage in any lawful activity in furtherance of its purpose, including, without limitation, the following:

- (1) To receive bequests, gifts, and/or grants of any and all real or personal property to further the purpose.
- (2) To develop programs to successfully raise funds to further the purpose.

Notwithstanding any of the above statements of purpose or power, the Corporation shall not, except to an insubstantial degree, engage in any activity or exercise any power that is not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. No substantial part of the activities of the Corporation shall be for the carrying on of propaganda or otherwise attempting to influence legislation, or for the participation or intervening in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

Upon the dissolution of the Corporation, its assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
