Our programs and services engage young students in powerful learning access the curriculum by helping teachers and scientist and engineer volunteers plan and implement exciting science learning experiences that take advantage of the wealth of local science, engineering, and environmental education resources.

Teacher Services: CRS provided over 1,000 kindergarten through 8th grade teachers with comprehensive information, references, personalized support, web-based resources, training, workshops, and other support related to science teaching and learning. CRS served classroom teachers in 100+ schools in the East Bay, including Oakland, Berkeley, Emeryville. CRS provided teachers with custom research and planning reports, and responded to over 1,000 individual teacher requests. The teachers we serve, together educate over 25,000 students, mainly in high-need, urban, under-resourced public schools.

4b (Code:) (Expenses \$ 126,728 including grants of \$) (Revenue \$)

Bay Area Scientists in Schools (BASIS): The CRS scientist and engineer volunteer program recruited, trained, and placed over 450 scientists and engineers into Kindergarten through 8th grade classrooms to present engaging, standards-based, hands-on science lessons. Scientists also serve as diverse, enthusiastic role models who inspire young students to learn about academic and career options in science and engineering. Scientist volunteer teams presented 450+ lessons in classrooms in 2013, engaging over 10,000 students in science learning activities. The lesson plans and related material resource information, science content background, and teaching tips are made available to classroom teachers hosting scientist team visits. The materials are also archived and accessible on the CRS website.

Research and Resource Development: Reserch, convening, consulting, and training projects targeting specific science education topics. CRS provided professional development and curricular development services to school districts and informal education organizations. CRS provided coordination for site-based pilot projects involving middle school science support linking scientists with middle school teachers and students. CRS convened Advisory Council meetings with thought leaders from business, academia, school districts, informal education organizations, scientists, and others working to improve the quality of K-8 science education.
