In 2021, Northeast Wisconsin Land Trust celebrated 25 years of successful land preservation. Over this time, the Land Trust learned to protect high quality natural lands throughout northeast Wisconsin. Preservation of these lands has an outsized impact on Lake Michigan's water quality, the region's biodiversity, and its climate resilience. Preserving local green space also promotes outdoor recreation, health, tourism, and the region's economic vitality.

Since our founding by a grassroots group concerned about water quality, we have grown substantially. The Land Trust has much to show for its first 25 years.

We have permanently protected 6,277 acres of land including 34.4 miles of shoreline and 1,023 acres of wetland. By filtering pollutants and providing ecological buffer zones, these lands protect the region's water, air quality, wild plants and animals, and help offset climate change effects.

We maintain Accredited status, a distinction held by fewer than 20% of land trusts nationwide. We were commended for our operational dashboard, sound finances, and strategic land selection.
