Wild Hearts Equine Therapy Center:

Thank you for choosing THE KELLER GROUP PA to assist with the 2021 taxes for Wild Hearts Equine Therapy Center. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will prepare the 2021 federal and state income tax returns for Wild Hearts Equine Therapy Center. We will depend on management to provide the information we need to prepare complete and accurate returns. We may ask management to clarify some items but will not audit or otherwise verify the data submitted.

In order for us to meet our own internal quality guidelines, all information necessary to complete your return must be in our possession not less than 30 days in advance of the filing deadline. In the event that you do not provide all information necessary by the thirty day deadline, you understand and agree that we are not obligated to complete your tax filing(s) by the due date and that we are not responsible for any interest, penalties or other consequences.

Accordingly, our engagement should not be relied upon to disclose errors, fraud, or other illegal acts, though it may be necessary for management to clarify some of the information submitted. We will inform management of any material errors, fraud, or other illegal acts we discover.

The law imposes penalties when taxpayers underestimate their tax liability. Call us if there are any concerns about such penalties.

Should we encounter instances of unclear tax law, or of potential conflicts in the interpretation of the law, we will outline the reasonable courses of action and the risks and consequences of each. We will ultimately adopt, on the behalf of Wild Hearts Equine Therapy Center, the alternative selected by management.

Our fee is based on our standard billing rates for the level of complexity of the work plus out-of-pocket expenses. Invoices are due and payable upon presentation. Returns will not be delivered to you or electronically filed before we receive payment. All accounts not paid within thirty (30) days are subject to interest charges to the extent permitted by state law. If your account is more than 30 days delinquent, we reserve the right to suspend services until the account is brought current. Suspension of services or a failure to pay an invoice may result in your returns not being prepared in time to meet filing deadlines or completed returns not being submitted. Returns not filed on time may be subject to penalties, interest and other consequences which you accept as a result of services being suspended or failure to pay an invoice.

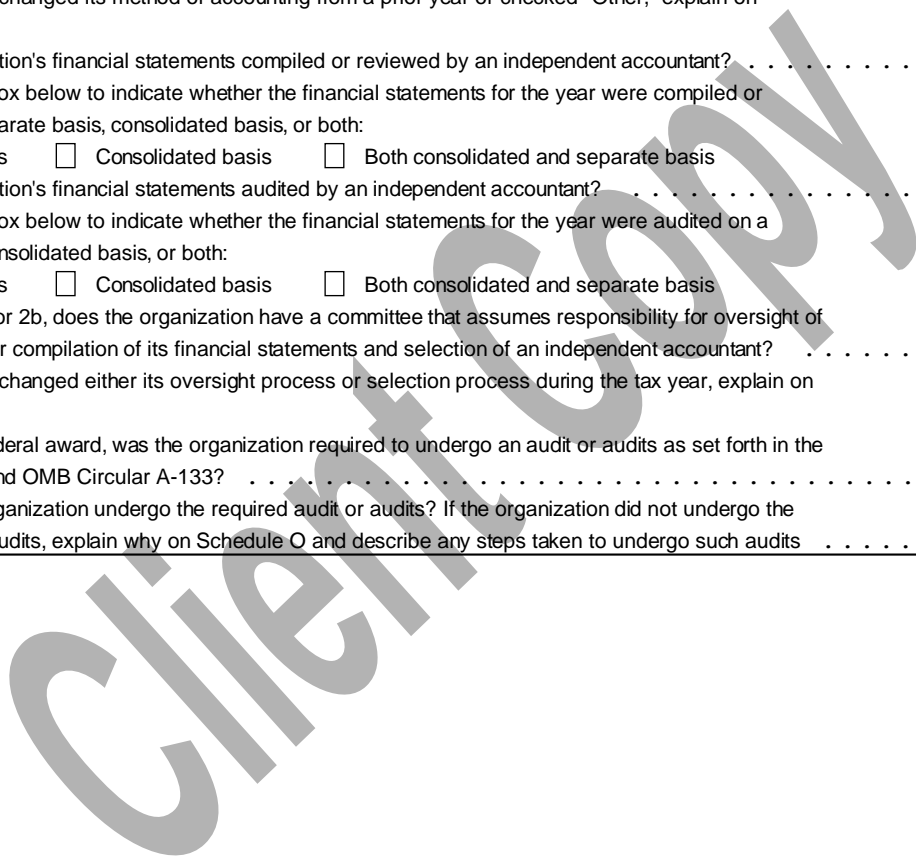

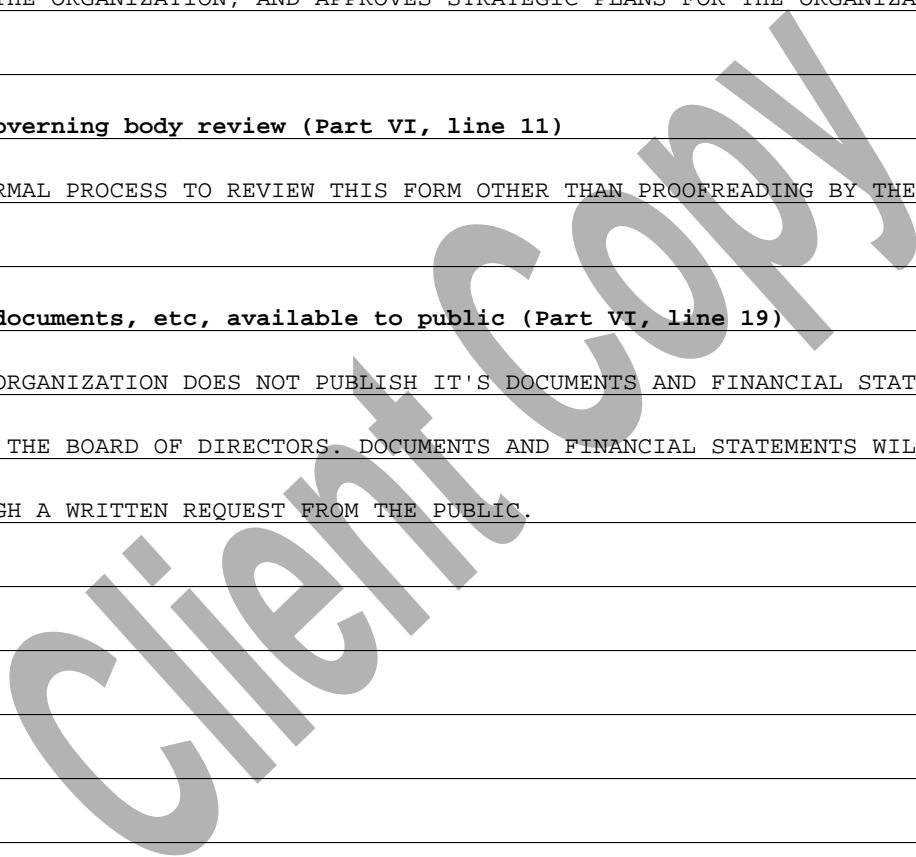
