Project Access Northwest collaborates with the health care community to open doors to medical and dental care for the low income individuals through a distributed network of donated care that assures appropriate access to medical and dental specialty care services.

Project Access Northwest links low income uninsured and underinsured King, Kitsap and Snohomish County patients to volunteer specialty providers in Project Access NW's distributed network of care. Working with the community health centers and free clinics for primary care services, Project Access NW assures access to needed specialty care services by providing care coordination services for the patients. Project Access NW assures that the client is eligible for services, that the pre-visit information such as labs and imaging are available to the specialists at the time of the scheduled appointment. Supported by our care coordinators, the patients have a better than typical no-rate (about 4% compared to 30+% for typical uninsured or Medicaid patients), are more likely to show up on time and be prepared to work

Project Access Northwest's Primary Link program continued to link uninsured and Medicaid emergency department users whose presenting diagnosis are for non-emergency health care needs with community health centers and other resources to assist the patient in getting his or her health care and other social service needs met in a less costly setting. Mid- 2016, the program also piloted serving Medicaid enrollees in the in-patient setting by making sure the patients had primary care visits scheduled prior to discharge - and the visits were within two weeks of discharge. In 2017 this program was put on hiatus to review the efficacy, efficiency and return on investment of the program for both funders and for the organization. In partnership with Coordinated Care, Project Access Northwest launched the Health Home

Project Access Northwest's Premium Assistance Sponsorship Program was developed late in 2013. Enrollees were able to purchase health care insurance in the Washington State Health Benefits Exchange, not eligible for AppleHealth (Medicaid) and unable to afford the remaining monthly premium even after federal subsidy via tax credits have been applied. In 2017, we were able to enroll and maintain health insurance for over 200 covered lives for the policy year that began in January and ended in December, 2017.
