YOUTH MENTAL HEALTH FIRST AID FOCUSES ON SKILLS TO PROVIDE INITIAL SUPPORT TO CHILDREN AND ADOLESCENTS (AGES 6-18) WHO MAY BE DEVELOPING A MENTAL HEALTH OR SUBSTANCE USE CONDITION.

NAMI HOMEFRONT LEADERS HAVE PERSONAL EXPERIENCE WITH MENTAL HEALTH CONDITIONS IMPACTING THEIR SERVICE MEMBER/VETERAN.

THEIR SPIRITUAL SUPPORT GROUP ADDRESSES THE NEEDS OF PEOPLE WHO USE SPIRITUALITY IN THEIR JOURNEY TO RECOVERY. THIS NONDENOMINATIONAL GROUP IS OPEN TO BOTH INDIVIDUALS LIVING WITH A MENTAL ILLNESS AND THEIR FAMILY MEMBERS. SPIRITUAL MENTAL WELLNESS RETREATS ARE OFFERED TWICE PER YEAR.

PEER WRITING SUPPORT GROUP WELCOMES ALL FORMS OF WRITING, FROM POETRY TO NOVELS. EACH WEEKLY MEETING IS LED BY ONE OF FOUR LEADERS. MEETINGS ARE DESIGNATED TO BE SUPPORTIVE OF ALL EXPERIENCE LEVELS.

PARTICIPANTS WILL LEARN ABOUT DIAGNOSES, TREATMENT, RECOVERY, COMMUNICATION STRATEGIES, CRISIS PREPARATION, AND RECEIVE NAMI RESOURCES. SEMINAR LEADERS HAVE PERSONAL EXPERIENCE WITH MENTAL HEALTH CONDITIONS IN THEIR FAMILIES.

FAMILY-TO-FAMILY WORKSHOP IS AN 8-WEEK COURSE FOR FAMILY CAREGIVERS OF INDIVIDUALS WITH SEVERE MENTAL ILLNESSES INCLUDING SCHIZOPHRENIA, BIPOLAR DISORDER, CLINICAL DEPRESSION, PANIC DISORDER, OBSESSIVE-COMPULSIVE DISORDER (OCD), AND MORE. THE COURSE DISCUSSES THE CLINICAL TREATMENT OF THESE ILLNESSES AND TEACHES THE KNOWLEDGE AND SKILLS THAT FAMILY MEMBERS NEED TO COPE MORE EFFECTIVELY.

YOUTH AMBASSADOR PROGRAM CONNECTS WITH SECONDARY STUDENTS IN EAST KING COUNTY TO ELEVATE THE VISIBILITY AND IMPORTANCE OF MENTAL WELLNESS AND SUPPORT TEEN MENTAL HEALTH CLUBS AND PROGRAMMING.
