1. EMERGENCY FINANCIAL ASSISTANCE PROVIDES TRADITIONAL ONE-TIME FINANCIAL AID FOR BASIC NEEDS, SUCH AS RENT, MORTGAGE OR UTILITIES. CLIENTS ARE SCREENED BY PHONE AND ONCE ELIGIBILITY IS DETERMINED, CLIENTS ARE SCHEDULED TO RECEIVE EMERGENCY FINANCIAL ASSISTANCE BY APPOINTMENT WITH OUR EMERGENCY SERVICES CASE WORKER.

2. EMERGENCY FOOD ASSISTANCE IS PROVIDED THROUGH OUR PEARLMAN PANTRY. FOOD CLIENTS ARE ELIGIBLE TO RECEIVE ASSISTANCE ONCE EVERY SIX MONTHS AND APPOINTMENTS ARE SCHEDULED BY PHONE TO RECEIVE FOOD ASSISTANCE. IN 2014, JFS PROVIDED FOOD FOR MORE THAN 76,000 MEALS TO INDIVIDUALS AND FAMILIES IN NEED.

THE CENTER FOR COUNSELING, GROWTH AND DEVELOPMENT ENCOMPASSES INDIVIDUAL, COUPLE, FAMILY AND GROUP MENTAL HEALTH COUNSELING SERVICES. ALL COUNSELORS AT THE CENTER FOR COUNSELING, GROWTH AND DEVELOPMENT HAVE MASTER'S DEGREES AND ARE LICENSED OR WORKING TOWARDS LICENSURE. IN 2014, JFS PROVIDED MORE THAN 1,200 MENTAL HEALTH COUNSELING SESSIONS SERVING OVER 500 CLIENTS. JFS IS ONE OF A FEW AGENCIES THAT OPERATE ON A SLIDING FEE SCALE TO MEET OUR CLIENTS' NEEDS DESPITE THEIR FINANCIAL MEANS.

VOLUNTEERS ASSIST IN OUR COMMUNITY FOOD PANTRY, ASSEMBLE AGENCY OR PROGRAM MATERIALS FOR DISTRIBUTION, SERVE ON ADVISORY COMMITTEES FOR ANNUAL FUNDRAISING EVENTS, DELIVER HOLIDAY MEALS TO HOMEBOUND INDIVIDUALS, AND COLLECT FOOD, TOYS AND SCHOOL SUPPLIES FOR DRIVES.
