TOWARD THE END OF THE YEAR, SMART VENTURED INTO THE ALASKAN YUKON FLATS THROUGH A COLLABORATIVE PROGRAM WITH THE COUNCIL OF ATHABASCAN TRIBAL GOVERNMENTS. SMART MEETINGS WILL BE LAUNCHED IN OR AROUND FORT YUKON IN 2018 AFTER EIGHT PEOPLE UNDERWENT THE FACILITATOR TRAINING.

IN 2017, CONNECTICUT LAUNCHED A PROGRAM THAT COULD BECOME A MODEL FOR MANY STATES: THE CONNECTICUT RECOVERY ORIENTED SUPPORT SYSTEM FOR YOUTH, ALSO KNOWN AS CROSS. SMART MEETINGS FOR TEENS AND YOUNG ADULTS AND SMART FAMILY & FRIENDS MEETINGS ARE BEING LAUNCHED TOGETHER IN AT LEAST 10 LOCATIONS ACROSS THE STATE. THIS IS PART OF A STATEWIDE RECOVERY INITIATIVE TO ADDRESS ADDICTION IN THE EARLY STAGES AND PROMOTE RECOVERY WITH THE TYPE OF POSITIVE FAMILY SUPPORT BUILT INTO THE CRAFT PROGRAM.
