We provide child care for parents who are taking English classes through our partners: Vermont Adult Learning and USCRI. For children, we offer a wide range of small and gross motor activities, socialization, developmentally focused play spaces, sensory activities, singing and story time. Our five-star licensed preschool is another of our programs. We provide preschool services to up to 18 children who are 3 to 5 years old. We use an emerging curriculum and diverse teaching team which focus on being outside and healthy social interactions, and being connected with students parents. We provide healthy snacks and meals for the class and encourage parents to be involved. During 2020, we have given an immense focus on meeting the basic needs of families, especially addressing food insecurity. We have been providing culturally appropriate foods, diapers, sanitizer, soap, masks and household supplies; as well as helping families pay for other necessities as it had been more imperative given the current rate of unemployment.
