4a (Code:) (Expenses \$ 195,558. including grants of \$) (Revenue \$) US Advocacy - MPV's local chapter network expanded with the addition of MPV-Boston; held a leadership retreat, and its third Celebration of Life gala, celebrating celebrating the lives of human rights defenders in the Muslim world who are adversely affected as a result of their advocacy. MPV engaged in legislation advocacy, appearing as amicus curiae on issues of separation of religion and State, women and LGBTQ+ rights, and with similarly aligned groups in voicing it's concern about pending legislation. Through it's local chapter, MPV engaged people at the grassroots level by hosting and participating in events such as Ask A Muslim; the "Is LGBTQI Halal?" workshop series in four cities; Ramadan Iftars; Pride parades; and...See Schedule O

4b (Code:) (Expenses \$ 52,842. including grants of \$) (Revenue \$) Global Initiatives - MPV continued in it's successful flagship international advocacy program, #ImamsForShe. Launched in 2015, #ImamsForShe seeks to support and empower imams, religious leaders, and Islamic scholars who debunk misogynistic interpretations of Islamic scripture that have led to human rights violations in the name of Islam against women and girls in Muslim communities. In 2018, MPV continued to Phase III with partner Alliance des Imams du Corridors Nord pour le Developpement Humanitaire (AICNDH), expanding existing programming and adding initiatives. For example, "La Femme en Islam" continued to air on national radio. The show now reaches 9.6 million people. A version of the initiative was also implemented in Tunisia.

4c (Code:) (Expenses \$ 35,526. including grants of \$) (Revenue \$) MPV at the United Nations- MPV has been engaged with the U.N., at the Human Right Council and its subsidiaries to ensure a progressive voice is heard at this crucial international fora. In January 2018, MPV was recommended by the U.N.'s Committee on Non-governmental Organizations to be accredited to the Economic and Social Council (ECOSOC). Accreditation allows access to U.N. high-level meetings and processes, such as the Commission on the Status of Women; the High-Level Political Forum; and the Human Rights Council. Further, MPV issued a report for the Universal Periodic Review of Saudi Arabia as part of a quadriennial review of their human rights performance. #ImamsForShe programming was also highlighted at CSW.
