IN TOTAL, THIS PROGRAM SERVED 758 RESIDENTS WHEN INCLUDING SPOUSES AND CHILDREN. WE DISTRIBUTED \$78,447 IN QUALITY OF LIFE FUNDS TO 153 FAMILIES TO HELP WITH BASIC NEEDS SUCH AS RENT, UTILITIES, MEDICATIONS, AND FUEL.
