THIS PROGRAM ASSISTED CLIENTS WITH MULTIPLE SERVICES TO CONNECT THEM TO NECESSARY RESOURCES SUCH AS ENERGY ASSISTANCE PROGRAMS, EMPLOYMENT, HOUSING, FOOD PROGRAMS, AND OTHER MEANS OF ASSISTANCE TO ENSURE CLIENTS BECOME MORE STABLE. CLIENTS WERE ALSO SERVED THROUGH A TOTAL OF 312 HOURS SPENT ON DIRECT ADVOCACY WORK WITH LANDLORDS AND OTHER AGENCIES ON THEIR BEHALF.
