Fierce Foods Academy - The Fierce Foods Academy is collection of programs that center on risk-reducing and quality-of-life-improving whole foods nutrition programming. The programs range from direct culinary education via live cooking classes to in-app workshops, professional health coaching, and social support. Our Fierce Foods Academy programs are administered and assessed by a Registered Dietitian, professional chef, and PhD in Public Health.

General Program - MaxLove Project is based in Southern California, though we do serve families nationally and even internationally with our online SuperFamilies Support Network, educational materials and resources, and our growing regional culinary medicine programs. With SoCal as our home base, we offer a number of unique therapeutic opportunities for families to gather in mutual support.

Love and Light - Our Love & Light program is a gift package that helps families initiate micro-actions associated with risk-reducing and quality of life changes such as healthy sleep, stress control, and nutrition. This package is mailed directly to childhood cancer families by request or to partnering hospitals. This mailing represents a welcoming starting place for most families in the MaxLove Project community. Upon receiving the package, childhood cancer parents are added to our online community for continual support, education, and resources. The kit is a place to begin that provides comfort in the hospital and at home. The goal of the Love + Light "Thrive Kit" is to make small habit and lifestyle changes easier and empowering. Our ideal outcome metric is for families to feel more supported and empowered in their journey after utilizing the tools included.
