This achievement was highlighted by the success of NAMI's Walk for Mental Health Awareness, which had over 2,000 participants. Additionally, the Suicide Awareness Conference raised and educated many participants regarding challenging topics that affect the community. In 2023, NAMI Miami-Dade County directly impacted over 5,250 participants through its Education Programs and Support Groups. The Organization reached over 4,270 youths and adults through its Ending the Silence Program which incorporates presentations focused on youth mental health and assisted nearly 1,000 helpline callers. The Peer and Family Mentor Program supported individuals and families through its one-on-one mentorship program and trained over 2,160 individuals in QPR Suicide Prevention Training.
