NEVERTHELESS, IN 2018-2019, VOLUNTEERS HELPED HIGH SCHOOL SENIORS--AND MORE JUNIORS THAN EVER--GET STARTED ON THEIR PERSONAL STATEMENTS FOR COLLEGE. ONE HUNDRED PERCENT OF TEACHERS SAID THE PROGRAM MET THEIR CURRICULAR NEEDS, AND 100% SAID THAT 826LA VOLUNTEERS WERE WELL-TRAINED IN SUPPORTING THEIR STUDENTS.
