The Mentoring Children of Prisoners Program provides guidance, encouragement, academic support, community activities, and strengthened family connections for the child of an incarcerated or formerly incarcerated parent through a one-to-one mentoring relationship with a caring adult. We served 1,378 matches and made 172 matches in 2015.

4b (Code: _____) (Expenses \$ 579,415. including grants of \$ _____) (Revenue \$ 5,034.)
Community-based Mentoring Program serves children facing adversity throughout metro Atlanta. Children and youth age 6-18 engage in educational, recreational, and cultural enrichment activities with volunteer adult mentors. The Hispanic Mentoring Initiative also follows the community-based model but targets youth of Hispanic descent who may come from homes where little English is spoken. We served 600 matches and made 128 matches in 2015. Mentoring Towards College (MTC) is a program designed to promote academic success in grades 4-12 and to ensure on-time graduation and college matriculation. It is an enhancement to our other programs, providing an additional layer of activities that promote academic achievement. We served 1,135 MTC matches in 2015.

The site-based mentoring program partners with corporations and schools to match children in one-to-one mentoring friendships. Activities are restricted to school grounds, where children meet with their mentors on a weekly or bi-weekly basis. Matches may focus on academic, social or personal development, based on the needs of the child. We served 161 matches and made 57 matches in 2015.
