Funding Scientific Research - We continued our in-person, digital and remote natural history studies for SLC13A5 with Citizen Corporation, Brown University, UT Southwestern, and Stanford University. These studies are key for our clinical trial readiness. We also funded basic and translational research in the US and Europe.

Education, Family Support and Awareness - We helped more families find an early and accurate diagnosis. We published in peer reviewed journals, held monthly family support groups, and funded key research to better understand the disease, and we have our first gene therapy drug in development.
