4a (Code:) (Expenses \$ 64,316 including grants of \$ 64,316) (Revenue \$) BGR awarded a \$64,316 grant to Moanoghar for the construction of a dormitory to provide shelter to children of the Chittagong Hill Tracts of Bangladesh affected by conflict or living in remote areas of the country. The grant will sponsor the construction of a three-story building with each floor providing accommodation to 40 children. This year's grant will also supply furnishings and school supplies. The dormitory will be built from bricks on a solid foundation. When the building is complete, it will accommodate 120 children in total-a permanent solution to the problem of accommodation for the students.

4b (Code:) (Expenses \$ 31,550 including grants of \$ 31,550) (Revenue \$) BGR awarded a \$31,550 grant to Bodhicitta Foundation. A portion of the grant sponsors the education and training of 30 teenage girls, providing school fees, clothes, shelter, books and all their other expenses. The girls come from some of the poorest regions in India, are in danger of child marriage or unable to finish high school and university due to poverty, and are being instructed in nursing, social work, and law as well as in job training so they can become agents of change and help others when they return to their villages. A portion supports a women's social services center benefiting roughly 2000 people per year that offers legal help to women facing divorce, domestic violence, and land disputes as well as job training to poor women in sewing, computers, English, beauty therapies, and so on. The legal service is offered for free by the previous batch of girls trained as lawyers and social workers. A portion of the grant supports a food program (6000 meals per year for undernourished slum children), youth groups, counseling, health and human rights workshops & interventions.

4c (Code:) (Expenses \$ 30,000 including grants of \$ 30,000) (Revenue \$) BGR awarded a \$30,000 grant to Hellen Keller International (HKI) to support their work in Western Kenya to improve access, delivery, and utilization of essential nutrition related services within a framework of Maternal, Newborn, and Child Health (MNCH) programs. With this grant, HKI is working with the Ministry of Health and other stakeholders to deliver proven programs to reach mothers, infants, and children in need of nutritional assistance at critical developmental stages. The project will improve delivery of nutrition health services, as well as offer access and training at the community level. HKI is also working with the Kakamega County Health Management Team to assess and act on the results of a baseline survey they are designing and implementing. Together these programs will have a direct impact on 55,000 adults (40,000 women) and 200,000 children, and will provide indirect benefits to an additional 380,000 community members.
