children to improve their mental/behavioral/social health and educational issues and to offer these children the possibility of a better life.

On Campus, SDCC provides children with mental/behavioral/social health and educational services. These services include counseling, individual/group/family psychotherapy, case management, medication management, therapeutic residential treatment for Rate Classification Levels 12 and 14 (the highest level of residential care in the State of California for children's mental health), day treatment, nonpublic schooling, foster family agency services and treatment, and wraparound services to support the transition of children back to biological/foster families.

The Campus' Residential facility offers 74 psychiatric residential beds to children from all over the State of California. In addition to mental health and educational services, the Campus' Residential children are offered opportunities to participate in sports, music and art programs, organic gardening, and field trips to places like Sea World, the San Diego Zoo, and the beaches. SDCC strives to give these children an opportunity to have a safe childhood experience away from the abuse, neglect and trauma many have already survived in their young lives. Children are supervised at a 3:1 or 4:1 ratio depending on their acuity. Staff are provided with specific training in intervention, communication, and various other techniques to provide appropriate and timely support for each residential child.

The Campus' WASC accredited school, The Academy, is staffed with special education teachers who are specially trained to educate children with significant mental/social/behavioral needs. Many of the children that arrive at SDCC also have significant delays in their education or have learning disabilities which may add to their mental/social/behavioral issues. In an effort to give these children the best learning opportunity, SDCC offers intensive reading programs, one-on-one instruction, and self paced schooling among other individualized learning pathways. The teacher to student ratio is a maximum of 8:1 with teacher assistants and child development counselors also in the classroom.

In the Community, SDCC provides public school based day treatment services with trained therapists and child development counselors participating in the classroom and providing after school therapy to meet the needs of children requiring that support. Additionally, our school based outpatient clinic provides individual and family therapy to children and families within the clinic, on school campuses, and in the home as necessary. Case management can be provided to access additional services to support the child or teen.

Community based programs also provide needed support for Foster Families who have chosen to become licensed to provide home environments for children with behavioral and mental health challenges. Parent support groups, respite services, continued training, and other

The Corporation and all of its businesses and other activities are to be operated and conducted in the promotion of its charitable purposes as specified in its articles of incorporation, and in the conduct of its affairs the management shall at all times be mindful of these charitable purposes.
