P.R.I.S.M.S., Inc. engages individuals with medical and scientific expertise to serve on its Professional Advisory Board, conducts an international conference.

PRISMS offered free membership for anyone interested in learning more about SMS and gaining access to all of PRISMS programs and services. PRISMS continues to sell the resource On the Road to Success with SMS, A Guidebook for Schools to families and professionals interested in learning more on these topics. Additional resources such as A Smith-Magenis Guidebook, Exploring Adult Residential Living are available on the PRISMS website free of charge.

4b (Code: ) (Expenses \$ 73,449 including grants of \$ ) (Revenue \$ ) In 2022, PRISMS promoted social media and awareness campaigns, including PRISMS birthday, SMS Awareness Day, and involvement in Rare Disease Day campaigns. PRISMS released informational brochures and bookmarks to increase understanding of the rare condition in communities around the world. PRISMS grew the Regional Representative program, an outreach program comprised of volunteer SMS family members around the world, to better provide support to newly diagnosed families and professionals.

4c (Code: ) (Expenses \$ 249,661 including grants of \$ ) (Revenue \$ 45,131 ) In 2022, PRISMS held its 11th International Conference. The 11th PRISMS International Conference brought together the Smith-Magenis syndrome (SMS) community for three days of connection and over 35 educational sessions focused on Smith-Magenis syndrome. It is the largest conference specifically focused on SMS in the world. This year, PRISMS hosted 313 total registrants, including 167 first-time attendees, 62 presenters, and 51 SMS individuals. In order to make the conference more accessible, PRISMS provided 34 conference scholarships to families and 12 to teachers and support staff to cover hotel and registration costs.

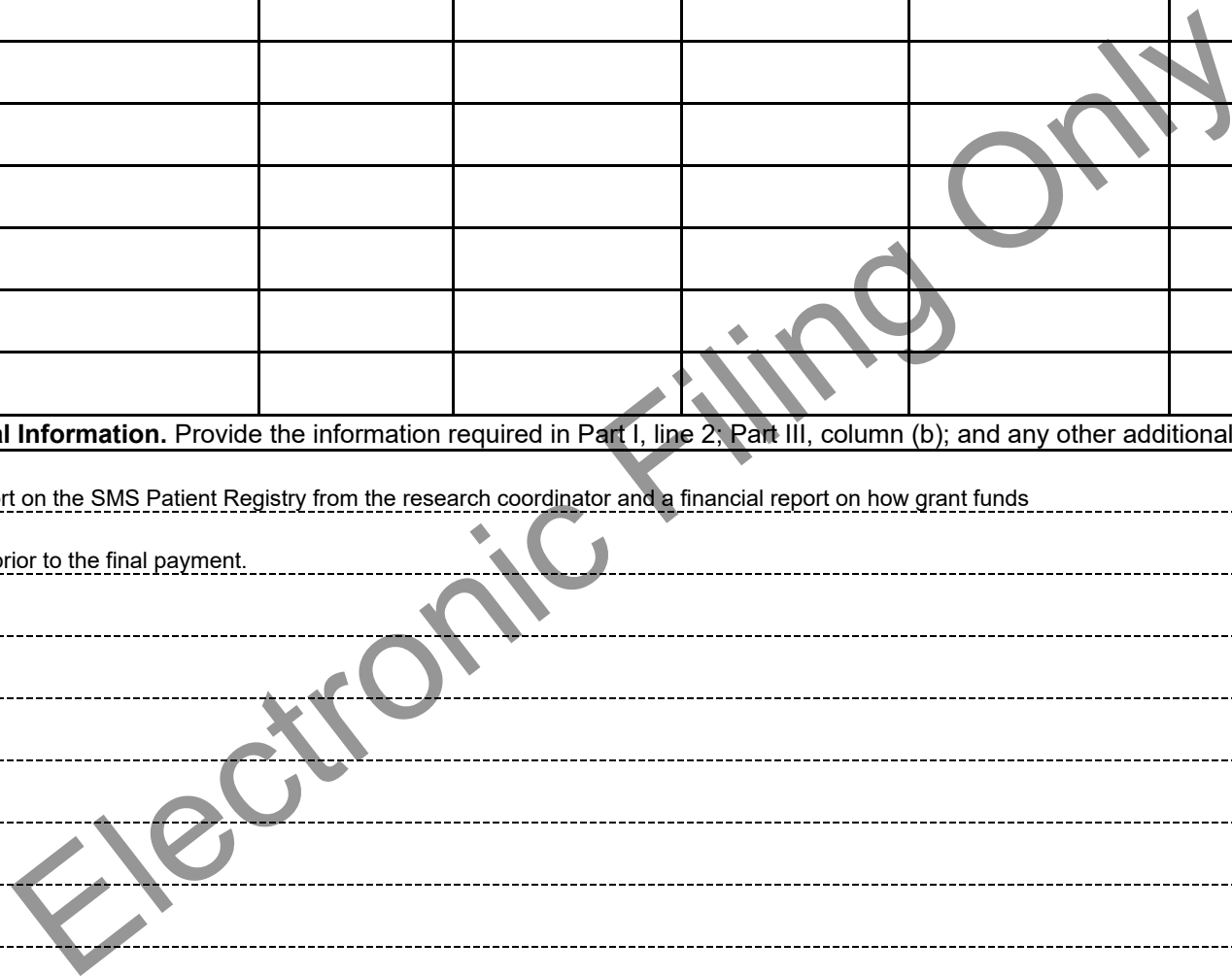
