THIS ALLOWS US TO ADVOCATE FOR THOSE DISPLACED BY CONFLICT AND NATURAL DISASTERS WITHOUT CONCERN OF REPERCUSSIONS. IN 2016, THE WORLD WITNESSED A GLOBAL REFUGEE CRISIS OF HISTORIC PROPORTIONS, WITH THE NUMBER OF REFUGEES AND DISPLACED PEOPLE REACHING 65 MILLION WORLD-WIDE - THE LARGEST NUMBER SINCE WORLD WAR II. MILLIONS FLED THEIR HOMES AND THEIR HOMELANDS BECAUSE OF WARS AND ARMED CONFLICTS, PERSECUTION, AND GENDER-BASED VIOLENCE IN MANY COUNTRIES AROUND THE WORLD INCLUDING SYRIA, IRAQ, SOMALIA, NIGERIA, MYANMAR, BANGLADESH, MEXICO AND CENTRAL AMERICA.
