THE SERVICES OF VOLUNTEERS ARE AN INDISPENSABLE PART OF THE ORGANIZATION'S PROGRAM ACTIVITIES. VARIOUS INDIVIDUALS CONTRIBUTED THEIR TIME WHICH RESULTED IN 7,279 VOLUNTEER HOURS WITH AN ESTIMATED FAIR VALUE OF \$383,000 FOR THE YEAR ENDED DECEMBER 31, 2016. WHILE SIGNIFICANT, THE VALUE OF THIS CONTRIBUTED TIME IS NOT REFLECTED IN THE TAX RETURN BECAUSE IT IS NOT SUSCEPTIBLE TO OBJECTIVE MEASUREMENT OR VALUATION AND THEREFORE DID NOT MEET THE CRITERIA FOR RECOGNITION UNDER ASC 958.605.30-11 "REVENUE RECOGNITION OF NOT-FOR-PROFIT ENTITIES."

DANA DORNSIFE IS FOUNDER AND PRESIDENT OF LAZAREX. SHE AND HER HUSBAND DAVID CONTRIBUTED \$813,694 TO LAZAREX DURING THE YEAR ENDED DECEMBER 31, 2016, WHICH COVERED MORE THAN 100% OF ALL GENERAL & ADMINISTRATIVE AND FUNDRAISING EXPENSES. ACCORDINGLY, ALL DONOR CONTRIBUTIONS RECEIVED FROM OTHER SOURCES WERE USED EXCLUSIVELY FOR PROGRAM - RELATED EXPENSES. LAZAREX INSISTS THAT ALL CONTRIBUTED INCOME BE ALLOCATED 100% TO ACTIVITIES PROMOTING THE MISSION OF THE ORGANIZATION TO SUPPORT END STAGE CANCER TREATMENT.
