Using the Preserve as an outdoor laboratory, students review what they have learned about ecosystems in the classroom and gain experience in wildlife monitoring and environmental research. Annually, the Preserve receives upwards of 10,000 visitors, the majority from across the state of NY and a few as far away as Turkey.
