WE ADDED 98 ACRES OF WETLANDS TO CHEROKEE MARSH AND 31 ACRES OF WETLAND ALONG THE YAHARA RIVER IN DANE COUNTY. WE PARTNERED WITH GREEN-ROCK AUDUBON SOCIETY TO MAKE A 75-ACRE PROPERTY AVAILABLE FOREVER FOR CONSERVATION EDUCATION IN ROCK COUNTY.
