These jobs may include design, performance, production crews, marketing, and front of house. Veterans in Art also provides military veterans free tickets to SCLA's performances. Other veterans programming includes performances and workshops. Additional program activity includes active community outreach and engagement.

 Shakespeare & Social Justice offers an urgent and innovative teacher training seminars that feature proprietary curriculum materials designed to illuminate Shakespeare's texts through social justice principles.
