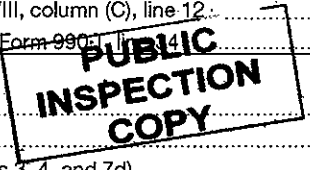

WE ADDRESS VIOLENCE ON SEVERAL FRONTS TO BUILD SAFE AND STRONG FAMILIES, PROMOTE HEALTHY PARENTING, HELP FAMILIES LEARN TO COMMUNICATE EFFECTIVELY AND CREATE STRONG BONDS, AND PROVIDE EMERGENCY SHELTER AND RESOURCES FOR VICTIMS ESCAPING VIOLENT HOMES.
