In pre-pandemic years, these programs included free cooking demos, educational exhibits, food and farm tours and sustainability talks to connect people and build community around healthy, seasonal food. In response to the pandemic we moved much of our adult programming online. This year we have begun returning to some in-person learning, and have been most successful in continuing our youth education programs, referenced above. Our goal in all of our programs is to provide the opportunity for our community to deepen their understanding of and engagement in sustainable food systems.
