The MAM Resale Store receives donations of clothing, furniture and other household items which are sold at low cost to MAM clients and the community in general. Qualified clients in MAM's service area who have limited income and cannot meet their basic needs without support are issued vouchers that may be used in the store for clothing and household items. 1,261 families qualified for such support in 2014. The store also serves as a site for court ordered community service and local volunteer organizations. Students from MAM's English as a Second Language Program also volunteer in the store in order to improve their speaking ability. Sales proceeds from the store help support MAM's mission.

Memorial Assistance Ministries' (MAM) mission is to assure that families have the means to meet their basic needs. To carry out our mission, MAM assists families facing financial crisis to avoid homelessness. MAM offers programs to enable long term financial self-sufficiency; to assure children have an improved school experience; and to facilitate client access to other support networks.

Form 990, Part III, Line 4a - Program Service Accomplishments

MAM's SELF-SUFFICIENCY PROGRAMS position families to meet their basic needs on their own with improved employment, financial coaching and English language skills. Heads of households in crisis become engaged in stabilizing their lives with access to Employment Services, Case Managed Assistance, English as a Second Language and complementary programs provided at MAM by partner organizations. In partnership with Catholic Charities' Cabrini Center for Immigration Legal Services, MAM made immigration education and application assistance available to the community. MAM assisted 688 people seeking employment in 2014 by providing them with the education, tools, and support needed to obtain gainful employment in order to stabilize the family; including 1,470 job coaching sessions and 1,054 computer training sessions. Additionally, 87 clients graduated from the Employment Certification program with 68% obtaining jobs. Case Managed Assistance supports a family in decreasing amounts for 3 months while the wage earner(s) find or return to work, balance their budgets, access public benefits if appropriate and pay off debt. In 2014, 219 families received case managed assistance through three program models. The average expenditure per family was \$1,879. 93% of families supported in this program were still housed 90 days post assistance. English as a Second Language offers 6 levels of basic and vocational English classes for a total of 62 classes to adult learners at 5 sites and evening classes are available at certain locations.

69% (382) of students who enrolled in classes completed their courses. 34 students took the Citizenship Preparation Classes and 6 became citizens of the United States of America. Immigration services clients may attend information sessions and have a brief consultation with an attorney or legal case worker at no cost. If the case is eligible for our services, a consultation fee will be charged at intake. In 2014, MAM offered these services in partnership with Cabrini Center for Immigration Legal Services for twelve months and served 274 unduplicated individuals. Also in 2014, MAM hosted 50 informational sessions, completed 696 filings, including 225 adjustments of status, 58 family petitions, and 161 employment authorizations. Complementary programs offered at MAM include free income tax services (2,941 returns with gross refunds totaling \$4.8 million), enrollment in public benefits (826 clients assisted in HCHD Gold Card, SNAP, Medicaid, CHIP registration), 112 clients assisted with Affordable care applications, mental health counseling (37 individuals in January and February 2014-beginning in March 2014 MAM provided family Counseling services and benefited 185 familite), Immunizations (1,410) and health screenings (216), vision screenings (178 individuals), GED (170 learners), financial literacy (321 clients) and legal counseling (391 individuals).

MAM offers FAMILY EMERGENCY ASSISTANCE to help families facing financial crisis avoid homelessness. This program includes: Shelter and Utilities, Medical/Health, Food/Household, and Clothing/Transportation. Shelter and Utilities assistance is a one-visit immediate third party bill payment for rent or utilities. It is available to clients once a year for a partial bill payment. In 2014, MAM served 1,669 families and paid up to \$240 per family for crisis assistance and 80% were still housed 90 days post assistance. In many cases this means that the primary wage earner will spend less time seeking assistance and more time earning a salary.

Children are able to stay in the school where they are enrolled, rather than transferring midyear. Medical/Health assisted 707 clients who received financial assistance to help pay for a doctor or dentist visit, or a prescription. Urgent health care can reduce workplace absenteeism, a root cause of unemployment and reduced wages and prevent more expensive emergency room visits. Food/Household assistance provided 289 sack lunches and MAM partners with two area food pantries to alleviate hunger, provided families home care packs with cleaning and toiletry items to relieve household expenses.

Clothing/Transportation: Families also qualify for clothing and transportation for work, job search or medical care. The MAM Resale Store distributes clothing and household items at no cost to residents in our service area who have limited income and cannot meet their basic needs without support. In 2014, 1,293 families qualified for clothing.

Transportation/Other: People seeking jobs are given Metro money or gasoline vouchers to go to an interview, and, in some cases, to go to work until they receive a first paycheck. The same transportation assistance is given to clients needing help getting to a doctor, dentist or pharmacy. MAM served 1,051 clients this way. MAM helped 224 people pay for documents necessary to find work, enroll children in school, etc. These included driver's licenses, birth certificates, and state ID cards. 793 clients received additional miscellaneous help with things such as personal grooming aids, home care packs or vouchers to buy specialty items deemed necessary.

PROGRAMS FOR CHILDREN IN SCHOOLS are designed to improve school experience for children from families with limited financial means and social networks. Back to School provided 5,568 school children in Spring Branch ISD and Cypress Fairbanks ISD with uniforms and in-kind school supplies for Aldine ISD. I Can See provided vision testing and glasses for 296 school children. 729 children from 269 families celebrated Christmas with gifts and food from Christmas Share. MAM is a registration site for Medicaid and CHIP and regularly offers immunizations. School nurses routinely refer sick children for doctor visits and prescription care.

Faith congregations in our service area are eligible for membership in Memorial Assistance Ministries. Members contribute volunteer staff, donations to the thrift store and funds for operating expenses.
