The MAM Resale Store receives donations of clothing, furniture and other household items which are sold at low cost to MAM clients and the community in general. Qualified clients in MAM's service area who have limited income and cannot meet their basic needs without support are issued vouchers that may be used in the store for clothing and household items. 1,556 families qualified for such support in 2017. The store also serves as a site for court ordered community service and local volunteer organizations. Students from MAM's English as a Second Language Program also volunteer in the store in order to improve their speaking ability. Sales proceeds from the store help support MAM's mission.

Memorial Assistance Ministries' (MAM) mission is to assure that families have the means to meet their basic needs. To carry out our mission, MAM assists families facing financial crisis to avoid homelessness. MAM offers programs to enable long term financial self-sufficiency; to assure children have an improved school experience; and to facilitate client access to other support networks.

Form 990, Part III, Line 4a - Program Service Accomplishments

Flood relief efforts - 2017 was an unusual year due to the enormous impact of Hurricane Harvey. Immediately post storm, on August 27, 2017, MAM's office on Blalock Road was opened with staff and volunteers who provided immediate assistance to impacted families. During the course of relief and recovery efforts throughout the fall of 2017, we continued to serve families in need of a variety of services. Typically, MAM conducts relief work during disasters; however, the magnitude of the hurricane demanded the support of all the organizations with the skills and processes to do this work which continues into 2018. In 2017, MAM flood relief assistance included the following:

- * 5,822 people from 1,645 families received some type of Hurricane Harvey relief service.
- * 1,294 families received financial assistance for temporary housing.
- * 348 people received clothing.
- * 42 people received transportation assistance.
- * 14 individuals received medical or pharmacy services.
- * 94 households received new furniture.
- * 1,807 families or 4,156 individuals received in-kind donations of cleaning supplies, diapers, water, toiletries, and household goods.

MAM offers FAMILY EMERGENCY ASSISTANCE to help families facing financial crisis avoid homelessness. This program includes: Shelter and Utilities, Medical/Health, Food/Household, and Clothing/Transportation. Shelter and Utilities assistance is a one-visit immediate third party bill payment for rent or utilities. It is available to clients once a year for a partial bill payment. In 2017, MAM served 2,816 families that received rent or utility assistance. Children are able to stay in the school where they are enrolled, rather than transferring midyear. Medical/Health assisted 618 clients who received financial assistance to help pay for a doctor or dentist visit, or a prescription. Urgent health care can reduce workplace absenteeism, a root cause of unemployment and reduced wages and prevent more expensive emergency room visits. Food/Household assistance provided 3,484 items to 1,807 households, this included home care packs (cleaning and toiletries), sack lunches and MAM partners with many area food pantries to alleviate hunger. Clothing/Transportation/Other: Families also qualify for clothing and transportation for work, job search or medical care. The MAM Resale Store distributes clothing and household items at no cost to residents in our service area who have limited income and cannot meet their basic needs without support. In 2017, 1,556 families qualified for clothing. People seeking jobs are given Metro money or gasoline vouchers to go to an interview, and, in some cases, to go to work until they receive a first paycheck. The same transportation assistance is given to clients needing help getting to a doctor, dentist or pharmacy. MAM served 647 clients this way in 2017. In 2017 MAM helped 153 people pay for documents necessary to find work, enroll children in school, etc. These included driver's licenses, birth certificates, and state ID cards.

MAM's SELF-SUFFICIENCY PROGRAMS position families to meet their basic needs on their own with improved employment, financial coaching and English language skills. Heads of households in crisis become engaged in stabilizing their lives with access to Employment Services, Case Managed Assistance, English as a Second Language classes, Citizenship preparation, Mental Health Counseling, Immigration Legal Services, Financial Literacy services and other complementary programs provided at MAM by partner organizations.

MAM assisted 1,025 people seeking employment in 2017 by providing them with the education, tools, and support needed to obtain gainful employment in order to stabilize the family. Job search skills, computer classes, employment coaching, workshops, and connections to vocational training and other services are provided throughout the year. 83% of those who completed all workshops found jobs. Case Managed Assistance which supports a family in decreasing amounts for 3 months while the wage earner(s) find or return to work, balance their budgets, access public benefits if appropriate and pay off debt. In 2017, 197 families received case managed assistance through both publicly funded and privately funded programs: The City of Houston's The Way Home Homelessness Prevention and Rapid Rehousing programs (70 client families) and MAM's STEP and Employment STEP programs (108 client families). In 2017, MAM hosted 55 English as a Second Language classes at 3 sites serving 719 adult students. In 2017, 210 adult students completed Citizenship Preparation Classes at MAM. Immigration Legal Services--MAM operates it's own immigration legal services program, staffed by experienced immigration staff attorneys and a legal caseworker. In 2017, MAM hosted 57 group information sessions with free one-on-one consultations with the staff attorneys. 1,014 individuals attended these sessions. MAM's immigration staff attorneys completed 261 contracts for services, and a total of 1,014 individuals received free, one-on-one

consultations. 100% of the applications submitted to adjust or request legal status in the United States had a favorable response. Staff attorneys also provided educational sessions in the community at 5 locations and conducted a DACA workshop for 24 DACA recipients looking to renew their status. In 2017, 361 families benefited from the Mental Health Counseling Program, which provides a range of clinically-appropriate mental health treatment services to individuals, families, and couples in English and Spanish. Broad diagnoses included depression, anxiety, adjustment disorder and post-traumatic stress disorder resulting from domestic violence, victims of crime, divorce, serious illness or death of a loved one. In 2017, MAM hosted financial literacy classes (366 clients) and offered clients financial coaching sessions (197 clients). Complementary programs offered at MAM include free income tax services (3,518 returns with gross refunds totaling \$5.2 million and EITC of \$2.1 million), 67 clients assisted with Affordable care applications, Immunizations (690) and health screenings (183), vision screenings (108 individuals), GED (176 learners) and legal counseling (403 individuals).

PROGRAMS FOR CHILDREN IN SCHOOLS are designed to improve school experience for children from families with limited financial means and social networks. Back to School provided 6,058 school children in Spring Branch ISD and Cypress Fairbanks ISD with uniforms and in-kind school supplies for Aldine ISD. I Can See provided vision testing and glasses for 146 school children. 765 children from 264 families celebrated Christmas with gifts and food from Christmas Share. MAM is a registration site for Medicaid and CHIP and regularly offers immunizations. School nurses routinely refer sick children for doctor visits and prescription care.

significant amounts of time in connection with programs, administration, and fundraising for which no amount has been recorded in the financial statements because the donated services did not meet the criteria for recognition under generally accepted accounting principles. The hours contributed by volunteers approximated 57,200 in 2017 and 57,000 in 2016, primarily in the Resale Store and Family Assistance programs. The Independent Sector and Bureau of Labor Statistics estimated the value of one hour of volunteer service in the United States at \$24.14 in 2017 and \$23.56 in 2016. Using these rates, the calculated value of volunteer services is approximately \$1,381,000 for 2017 and \$1,343,000 for 2016.

IN-KIND SERVICES PROVIDED TO PARTNERS- In 2017, MAM provided the use of their facilities to twelve not-for-profit and other partners who provide services to people in the community. The estimated value of the facilities provided in 2017 and 2016 was approximately \$39,000 and \$38,000, respectively.
