COVID-19 - IN RESPONSE TO THE COVID-19 OUTBREAK, RICHMOND PUBLIC SCHOOLS CLOSED ALL SCHOOLS ON MARCH 15, 2020 AND TRANSITIONED TO A VIRTUAL LEARNING FORMAT. VIRTUAL LEARNING WAS AN ESPECIALLY SIGNIFICANT CHALLENGE FOR THE STUDENTS AND FAMILIES OF RPS, MANY OF WHOM DID NOT HAVE HOME COMPUTERS OR INTERNET ACCESS NEEDED FOR ONLINE SCHOOL. THE FOUNDATION RESPONDED TO THIS CHALLENGE BY RAISING \$775,000 FOR THE PURCHASE OF CHROMEBOOKS AND INTERNET HOTSPOTS. IN ADDITION, THE FOUNDATION RAISED FUNDS TO PROVIDE FOOD FOR STUDENTS AND THEIR FAMILIES.
