Dear Friends,

We have enjoyed a long relationship with Cat's Cradle of the Shenandoah Valley, Inc. as a grantee and participant in our professional development offerings. That relationship expanded in 2021 when Cat's Cradle established a substantial Agency Fund at our Community Foundation.

The creation of this Agency Fund was made possible thanks to a generous contribution Cat's Cradle received from one of their donors. That gift was contingent on it being used to establish a fund to make it possible for Cat's Cradle to take the huge step forward of hiring an Executive Director, rather than continuing to function under a working board structure.

Our Agency Fund distributions to Cat's Cradle, which will not begin until later this year or early 2023, will provide an ongoing source of income to offset expenses related to the establishment and maintenance of a regular, full-time Executive Director. The Agency Fund is not intended to provide ongoing support for existing or future programs, nor is it intended to replace fundraising and donor development for such programs.

Accounting standards required Cat's Cradle to recognize the entirety of their donor's significant contribution (\$1,400,000.00) as income in 2021. When they transferred those funds to the Community Foundation shortly thereafter, Cat's Cradle created a new asset that they will continue to reflect on their balance sheet. As we issue our annual distributions from this Agency Fund to Cat's Cradle to underwrite the Executive Director's salary and related expenses, they are to reduce this asset accordingly.

Due to how nonprofit organizations such as Cat's Cradle account for their Agency Funds at the Community Foundation, it is important for you as a grantor to know that our Agency Fund distributions will not appear as Revenue on their Federal tax returns. As a result, Form 990 for each of their fiscal years beginning with 2022 may give the appearance of an operating deficit, even though Cat's Cradle will have received their Agency Fund distribution in an amount based on the Agency Fund agreement and which Cat's Cradle can disclose to you.
