WE ALSO BRING TEAMS OF 826 STAFF AND VOLUNTEER TUTORS TO PARTNER SCHOOLS WHERE WE SUPPORT STUDENTS 3:1 WITH WRITING PROJECTS. IN FY23, WE SUPPORTED 16 TEACHERS AND 570 STUDENTS AT 5 SCHOOLS, ESTABLISHING REGULAR WEEKLY PARTNERSHIPS WITH CLASSROOMS AND SUPPORTING A VARIETY OF WRITING PROJECTS. ONE HIGHLIGHT WAS OUR YOUNG AUTHORS BOOK PROJECT IN SPRING 2023.
